AGREEMENT FOR PAYMENT OF DELINQUENT TAXES

W I T N E S S E T H:

WHEREAS, TAXPAYER owes delinquent Personal Property Taxes costs in the amount of \$ _____ on the following Personal Property Taxes described as Accounts# _____

WHEREAS, TAXPAYER has agreed to make an initial payment of \$ _____ and to pay the remaining sum in monthly or weekly installments; and

WHEREAS, TREASURER desires to enter into such an agreement to provide for the payment of the balance due \$ _____ in installments at this time;

NOW, THEREFORE, for and in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

1. TAXPAYER hereby agrees to pay to the County of Dinwiddie, Virginia, the remaining sum (plus interest each month thereafter) in installments to bring the account current in the following manner:
 - a. Beginning on the ___ day _____ of, TAXPAYER agrees to pay the minimum amount of \$ _____
 - _____ weekly
 - _____ semimonthly (1st and 15th of the month)
 - _____ monthly, to be received by the 30th of each month
 - b. TAXPAYER further agrees to contact TREASURER for the amount of the final payment.
 - c. Payments should be made payable to the Treasurer, County of Dinwiddie.

- d. All such sums shall be paid either by direct debit or in person at the Treasurer's office, or mailed to: Office of the Treasurer, County of Dinwiddie, Post Office Box 178, Dinwiddie, Virginia 23841
 - Adjustments or closure to any ACH debit authorizations or direct debits must be made in writing to the TREASURERS office five (5) business days in advance of the next debit.
- e. Checks returned to the Treasurer's office marked "Insufficient Funds" and not honored within 10 days may jeopardize this agreement, and are subject to a return check charge of \$35.00.
2. This Agreement is entered into in accordance with Section 58.1-3919 of the *Code of Virginia*.
3. TREASURER and TAXPAYER agree that TAXPAYER may prepay any amounts due by the agreement and pay the sum due at any date earlier than the final payment date.
4. If TAXPAYER, during the term of this installment agreement, defaults upon obligations arising under this agreement or defaults on any current obligation as it becomes due, this agreement shall be voidable upon 15 days' written notice by the TREASURER and further collections against TAXPAYER will commence.
5. In the event TAXPAYER defaults on this installment agreement, said TAXPAYER shall not be eligible for another agreement within three years of such default. The undersigned irrevocably authorizes _____(attorney)_____ to appear in the Dinwiddie County Circuit Court and confess a judgment without process in favor of Dinwiddie County for such amount as may then appear unpaid hereon, and to consent to immediate execution upon such judgment.
