IN RE: MINUTES

The minutes of the previous meeting were read and approved.

IN RE: PAYMENT OF CLAIMS

Upon motion of Mr. Tunstall, seconded by Mr. Watkins, all five members voting "aye", it is ordered by the Board that the accounts against the following funds for the month of October 1971, be issued payable out of the respective accounts. General Fund - Checks numbering 71-1385 through 71-1535 amounting to \$61,416.43.

IN RE: EXTENSION AGENT - SWANSON JENNINGS

Mr. Swanson Jennings, Extension Agent, Dinwiddie County, gave a report on the peanut crop in the County for the year 1971. He stated that due to the weather, there had been a reduction in the crop of at least 25%.

IN RE: SHOOTING RANGE PERMIT - DINWIDDIE RURITAN CLUB

This shooting range permit having been introduced at the October 20th meeting, meeting all requirements, upon motion of Mr. Hargrave, seconded by Mr. Tunstall, all five members voting "aye", this shooting range permit was approved.

IN RE: TREATMENT OF COURTHOUSE - TERMITES

The following bids were submitted for treatment of the courthouse for termites:

Dodson Bros. \$900.00; B. L. Houchens Pest Control - \$800.00;
Union Termite Control Co. - \$770.00; Orkin - \$675.00

Upon motion of Mr. Hargrave, seconded by Mr. Winn, all five members voting "aye", the Orkin Co. was awarded the contract to treat the courthouse for termites. This contract did not include an annual treatment or inspection.

IN RE: EARL GWALTNEY

Mr. Earl Gwaltney requested that the Board authorize him to use county gas in his personal car while on duty as a special policeman.

The Board was in complete agreement that if they allowed compensation in any way to any member of any volunteer group, that they would have to do it for all.

The Chairman told Mr. Gwaltney that the Board was aware of the work done by the special police, but was sorry they could not grant his request.
